## Volunteer Release and Waiver of Liability

This **2019 Washington County Volunteer Expo Volunteer Release and Waiver of Liability** (the "Release") is executed on this \_\_\_\_\_ day of \_\_\_\_\_, 2019, by \_\_\_\_\_ (the "Volunteer"), in favor of the United Way of Washington County, Maryland, Inc., a Maryland non-profit corporation, its officers, directors, employees, agents, donors, volunteers, member agencies and any other organization, corporation, entity, or Washington County resident with which United Way partners to produce the 2019 Washington County Volunteer Expo (collectively the "United Way").

The Volunteer desires to exhibit as a nonprofit or volunteer-based agency for United Way and is aware of the wide range of activities associated with exhibiting for Washington County Volunteer Expo and has made a voluntary choice to engage in these activities.

The Volunteer does hereby freely, voluntarily and without duress execute this Release under the following terms:

1. **Waiver and Release.** In consideration of being permitted to participate in the Washington County Volunteer Expo, Volunteer agrees to release and forever discharge and hold harmless the United Way, its successors and assigns, collectively or individually, from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's work as part of the Washington County Volunteer Expo. This includes all work being undertaken at Robinwood Professional Center but not limited to, United Way member agencies, other non-profit organizations, volunteers who attend this event, and any other party having a legal interest in the Washington County Volunteer Expo.

Volunteer acknowledges that this Release forever discharges United Way from any and all liability, claim or cause of action that the Volunteer may have against United Way with respect to any bodily injury, personal injury, illness, loss, death or damage to personal property that may result directly or indirectly from Volunteer's work relating to the Washington County Volunteer Expo. Volunteer also acknowledges that United Way does not assume any responsibility for or obligation to provide financial assistance or any other assistance, including but not limited to medical, health or disability insurance in the event of injury or illness to the Volunteer arising from the Washington County Volunteer Expo.

2. **Medical Treatment.** Except as otherwise agreed to by United Way in writing, Volunteer does hereby release and forever discharge United Way from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, medical care or service rendered in connection with the Volunteer's work relating to the Washington County Volunteer Expo.

3. **Assumption of Risk.** The Volunteer acknowledges that the work undertaken as part of the Washington County Volunteer Expo may include activities that may be hazardous to the Volunteer. Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities and releases United Way from any and all liability for injury, illness, death or property damage resulting from the Volunteer's activities relating to the Washington County Volunteer Expo.

4. **Insurance.** The Volunteer acknowledges that United Way does not carry or maintain health, medical or disability insurance coverage for any volunteer. **EACH EXHIBITOR / NON-PROFIT AGENCY IS ENCOURAGED TO OBTAIN HIS OR HER OWN MEDICAL AND/OR HEALTH INSURANCE COVERAGE.**

5. **Photographic Release.** Volunteer agrees to and permits United Way to take photographic images and video and audio recordings of him/her during his/her work relating to the Washington County Volunteer Expo. Volunteer also grants and conveys to United Way all rights, titles and interests in said photographic images and video and audio recordings, including but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings. Volunteer further consents to and authorizes United Way to use and reproduce said photographic images, video and audio recordings and to circulate and publicize the same by all means, including but not limited to, newspapers and other print media, television media, brochures, pamphlets, marketing materials and websites.

6. **Other.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted under the laws of the State of Maryland, and this Release shall be governed by and interpreted in accordance with the laws of the State of Maryland. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be in full force and effect.

7. **Effective Date.** This Release shall be effective immediately upon execution and shall cover any and all work Volunteer performs before, during and after April 10, 2019, in relation to Washington County Volunteer Expo.
